1. PRIVACY STATEMENT

1.1. This Privacy Policy of XMR Markets (Pty) Ltd (2015/241042/07), an authorized financial services provider (FSP license number: 46452), with its office address at 33 Scott Street, Waverley, Johannesburg, 2090, South Africa, is made in order to protect the privacy and safeguarding the personal and financial information of our clients and Website visitors is one of our highest priorities. We are committed to protecting the privacy of our users and complying with applicable Protection of Personal Information Act 4 of 2013 (POPIA) and other data protection laws. Grodena Ltd is a registered company in Cyprus, with registration number HE 438008 and registered address is Nisi 68, Agia Napa, 5330, Famagusta, Cyprus. Grodena Ltd is appointed as an Independent representative and Distributor.

1.2. PRINCIPLES OF POPIA COMPLIANCE

Accountability

XMR Markets is committed to maintaining accountability for the processing of personal information and ensuring compliance with POPIA.

Processing Limitation

Personal information will only be processed for legitimate purposes, and we will ensure that the processing is lawful, adequate, and relevant.

Purpose Specification

XMR Markets will specify the purposes for which personal information is collected, and data subjects will be informed of these purposes.

Data Minimization

We will only collect and process personal information that is necessary for the intended purpose and will not retain it for longer than required.

Information Quality

We will take reasonable steps to ensure that personal information is accurate, complete, and up-to-date.

Openness and Transparency

XMR Markets will be transparent about how personal information is processed, and data subjects have the right to access their personal information.

Security Safeguards

We will implement appropriate security measures to protect personal information against unauthorized access, disclosure, or loss.

Data Subject Participation

Data subjects have the right to access, correct, or request the deletion of their personal information, and XMR Markets will facilitate these rights.

1.3. The following Privacy Statement explains how we collect and protect your information. By opening an account or by using our Web site, you give your consent to the collection and use of personal information by us as explained in this privacy statement.

2. COLLECTION OF PERSONAL INFORMATION

- 2.1. We collect information required to open an account, to transact business effectively and to safeguard your assets and your privacy. To do this, we gather information to help us assess your needs and preferences.
- 2.2. The information we collect directly from you includes information required to communicate with you, including your name, mailing address, telephone number, e-mail address and to identify who you are. We also collect demographic information when you open an account, including, birth date, education, occupation, etc. and information about your transactions with us. We also assess your trading experience, your approximate annual income and



approximate net worth to assess your financial position.

3. USAGE OF PERSONAL INFORMATION

3.1. We use personal information only as appropriate to provide you quality service and security. For example, we may use the information collected from you to verify your identity and contact information. We may also use this information to establish and set up your trading account, issue an account number and a secure password, maintain your account activity, and contact you with account information. This information helps us improve our services to you, customize your browsing experience and informyou about additional products, services or promotions that may be of interest to you.

4. OUR AFFILIATES AND PARTNERS

4.1. We may share information with affiliates if the information is required to provide the product or service you have requested or to provide you the opportunity to participate in the products or services our affiliates offer. We may also forge partnerships and alliances, which may include joint marketing agreements, with other companies who offer high-quality products and services that might be of value to our clients. Inorder to ensure that these products and services meet your needs and are delivered in a manner that is useful and relevant, we may share some information with partners, affiliates and alliances. This allows them to better understand the offers that are most relevant and useful. The use of your personal information is limited to the purposes identified in our relationship with the partner or affiliate.

5. NON-AFFILIATED THIRD PARTIES

- 5.1. We do not sell, license, lease or otherwise disclose your personal information to any third party for any reason, except as described below.
- 5.2. We reserve the right to disclose your personal information to third parties where required by law to regulatory, law enforcement or other government authorities or when necessary to protect our rights or property.
- 5.3. To help us improve our services to you, we may engage another business to help us to carry out certain internal functions such as account processing, order fulfilment, client service, client satisfaction surveys or other support services or data collection activities relevant to our business. We may also provide a party with client information from our database to help us to analyse and identify client needs and notify clients of product and service offerings. Use of the information shared is strictly limited to the performance of the task we request and for no other purpose. All third parties with whom we share personal information are required to protect personal information in a manner similar to the way we protect personal information.

6. **SECURITY**

- 6.1. All information you provide to us is stored on secure servers. Any payment transactions will be encrypted using SSL technology. Where we have given you (or where you have chosen) a password which enables you to access certain parts of our Web site, you are responsible for keeping this password confidential. We ask you not to share a password with anyone.
- 6.2. Unfortunately, the transmission of information via the Internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our Web site; any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.

For this purpose, pixel tags (also called clear gifs or web beacons) may be used to note the pages you have visited.
